**NOTICE OF SUSPENSION**  
**(By Consent)**

**Notice Issued: April 19, 2023**

David L. Wisz, P 55981, Birmingham, Michigan, by the Attorney Discipline Board Tri-County Hearing Panel #57

Suspension - 30 Days, Effective April 13, 2023<sup>1</sup>

Respondent and the Grievance Administrator filed a Stipulation for Consent Order of Discipline which was approved by the Attorney Grievance Commission and accepted by the hearing panel. The stipulation contains respondent's admission that he was convicted on March 11, 2022, of one count of disorderly person, a misdemeanor offense, in violation of MCL 750.167, in a matter titled *People v David Leonard Wisz*, 52/3 District Court Case No. 21-004466-SM.

Based on respondent's admissions and the parties' stipulation, the panel found that respondent violated a criminal law of a state or of the United States, an ordinance, or tribal law, which constituted professional misconduct under MCR 9.104(5).

In accordance with the stipulation of the parties, the hearing panel ordered that respondent's license to practice law in Michigan be suspended for 30 days, effective April 13, 2023. Total costs were assessed in the amount of \$943.00.
